Notice Regarding Acquisition of Shares in Hein Verpackungen GmbH
by Our Consolidated Subsidiary, Antalis

We hereby announce that Antalis GmbH (located in Frechen, Germany), an operating company of Antalis S.A.S. (located in Paris, France, "Antalis"), which is a consolidated subsidiary of the Company, has acquired all shares of Hein Verpackungen GmbH (located in Nuremberg, Germany; "Hein Verpackungen"), a company engaged in the packaging business in Germany.

1. Reason for the Shares Acquisition

Since its establishment in 1928, Hein Verpackungen has provided custom-made packaging materials and POS displays to manufacturers of daily consumer goods as well as automotive and electronics industries, primarily in southern Germany. The company's strength lies in its ability to provide integrated services covering the entire process from product design, processing through molding and sales. Through its high-quality products and flexibility, the company has built strong and trusted relationships with its customers.

Antalis has been continuously transforming its business portfolio by expanding its packaging and visual communication businesses. Germany is one of Antalis's most important European markets due to its large market size. Following the acquisition of the BB Pack Group in 2022, this transaction represents part of Antalis's diversification strategy within the growing German packaging market.

Through this acquisition, Antalis expects to strengthen its customer base in Germany, enhance its product development capabilities, expand packaging solutions by internalizing processing functions, improve profitability and cost structures, and enhance logistics efficiency through collaboration with existing German subsidiaries
