Annualized premium of new business was 193 million yen, 179% of July 2017

TOKYO, August 7, 2018 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: <http://ir.lifenet-seimei.co.jp/en/>) announces the monthly business performance for July 2018.

Annualized premium*¹ of new business in the month of July 2018 was 193 million yen (179% of July 2017) with the number of new business at 4,477 (190% of July 2017). Accordingly, annualized premium*¹ of policies-in-force was 11,663 million yen. The number of policies-in-force as of the end of July 2018 resulted in a total of 275,911, and sum insured of policies-in-force stands at 2,122,045 million yen.

In July 2018, insurance premiums and claims and benefits recorded 951 million yen (112% of July 2017) and 155 million yen (86% of July 2017), respectively.

Lifenet's steady growth of policies-in-force has been driven by the public's increasing support and interest in its Manifesto; to offer simple, convenient and competitively priced products and services based on the highest levels of business integrity.
