Annualized premium of new business was 243 million yen, 168% of November 2017

TOKYO, December 7, 2018 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: <u>https://ir.lifenet-seimei.co.jp/en/</u>) announces the monthly business performance for November 2018.

Annualized premium^{*1} of new business in the month of November 2018 was 243 million yen (168% of November 2017), and the number of new business was 5,750 (171% of November 2017). Annualized premium^{*1} of new business for the first eight months of fiscal 2018 was 1,731 million yen, and exceeded that for the whole of fiscal 2017.

Accordingly, annualized premium^{*1} of policies-in-force was 12,363 million yen. The number of policies-in-force as of the end of November 2018 resulted in a total of 292,159, and sum insured of policies-in-force stands at 2,204,082 million yen.

In November 2018, insurance premiums and claims and benefits recorded 1,000 million yen (114% of November 2017) and 275 million yen (217% of November 2017), respectively.
