Number of new business was 6,504 (158% of February 2018), a record high result for the second consecutive month

TOKYO, March 7, 2019 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: https://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for February 2019.

Annualized premium^{*1} of new business in the month of February 2019 was 277 million yen (157% of February 2018) with the number of new business at 6,504 (158% of February 2018), setting a new monthly record following the result in January 2019.

Accordingly, annualized premium*1 of policies-in-force was 12,900 million yen. The number of policies-in-force as of the end of February 2019 resulted in a total of 304,770, and sum insured of policies-in-force stands at 2,268,624 million yen.

In February 2019, insurance premiums and claims and benefits recorded 1,044 million yen (116% of February 2018) and 120 million yen (87% of February 2018), respectively.
