# Notice of Termination of Strategic Alliance Agreement between Lifenet and Swiss Re Life Capital

TOKYO, April 26, 2021 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President: Ryosuke Mori, URL: <a href="https://ir.lifenet-seimei.co.jp/en/">https://ir.lifenet-seimei.co.jp/en/</a>) hereby announces that the Strategic Alliance Agreement (the "Agreement") with Swiss Re Life Capital Ltd ("SRLC") has terminated on April 25, 2021 due to the expiration of the term of agreement.

#### 1. Background of the termination of the Strategic Alliance Agreement

In April 2013, Lifenet entered into the Agreement with Swiss Reinsurance Company Ltd. Due to a change of shareholding company within the Swiss Re Group, in March 2017, the Agreement was re-signed with SRLC. Through the Agreement, both parties benefited from mutual business expansion through knowledge sharing and collaboration in areas such as online distribution, product development and underwriting. Over the last eight years, Lifenet has greatly increased its policies in-force from approximately 170,000 at the time of commencement of alliance to approximately 430,000 (as of March 2021), while gaining a broad range of experience as a life insurance company. Having confirmed that Lifenet has achieved its set goals as a result of this business alliance, and so that both parties may continue to achieve further growth in a changing business environment and an ongoing pandemic, the Agreement has been terminated, which expired as of April 25, 2021.
